HEMATITE TOWNSHIP BALLFIELD RESOLUTION FOR DEDICATION AND COMMEMORATIVE SIGN

OBJECTIVES AND PURPOSE:

- A) The sign aims to recognize and honor the contributions, achievements, or significance of Chrissy Joy Odlund Johnston, Ernie Callovi, Stanley Lang, Laverne Tusa, Jack Honkala, Bob Francisco, Bryan "Chung" LaChapelle.
- B) The chosen location should be accessible to the public and provide adequate visibility for the sign.
- C) Considerations should be made for the site's historical or cultural relevance, as well as its suitability for public engagement and aesthetic integration.

DESIGN AND SPECIFICATIONS:

- A) A committee has been appointed by the Township to oversee the design and selection process.
- B) The design will reflect the essence, achievements, or symbolism associated with Chrissy Joy Odlund Johnston, Ernie Callovi, Stanley Lang, Laverne Tusa, Jack Honkala, Bob Francisco, Bryan "Chung" LaChapelle.
- C) The sign's materials, dimensions, and construction specifications shall be in line with industry standards, ensuring durability, safety, and preservation.
- D) The signage will only allow publicly acceptable information as decided by the Hematite Township Board.
- E) The names of Chrissy Joy Odlund Johnston, Ernie Callovi, Stanley Lang, Laverne Tusa, Jack Honkala, Bob Francisco, Bryan "Chung" LaChapelle. Are the full legal first name with any "nickname" placed in between the first and last name or immediately below the full name.

FUNDING AND RESOURCES:

- A) The Township shall accept appropriate funding from donations given to the Township through its budget in the amount of \$500.00 origination fee to cover the expense related to the sign's installation, and maintenance.
- B) Funding will be sought from public-private partnerships, sponsorships, or donations, subject to relevant regulations and transparency.
- C) The actual cost of creating future additions and maintenance for new additions shall be funded by the individual or organization proposing the name (s) of Chrissy Joy Odlund Johnston, Ernie Callovi, Stanley Lang, Laverne Tusa, Jack Honkala, Bob Francisco, Bryan "Chung" LaChapelle.
- D) Nominations for the additions can be submitted annually at the June Township board meeting with additions to be added at a July fourth celebration.


UNVEILING AND DEDICATION:
