

HEMATITE TOWNSHIP BOARD MEETING MINUTES

SEPTEMBER 13, 2023

Meeting was called to order by Supervisor Joe Hoenig. Pledge of Allegiance was recited. ROLL CALL: All members present. ACCEPT AGENDA – Trustee Raduechel made motion to approve agenda as presented and supported by Trustee Richardson. PUBLIC COMMENT: NONE MINUTES REVIEW AND ACCEPTANCE: Treasurer Haag made motion to approve minutes as presented and supported by Trustee Raduechel.

FIRE DEPARTMENT REPORT: 2 Calls for the month of August. Tires from the Brush Truck have been changed and old tires will be used for the Maintenance truck.

WATER DEPARTMENT REPORT: Still waiting for the Freeze plates and are in need of some new meters. All water customers received a .96 credit to the last bill as the calculation was incorrect. The new corrected rate is 40.11 per month.

LIQUOR INSPECTIONS – SUBMITTED WITH NO VIOLATIONS.

OLD BUSINESS: A) WATER SHUT OFFS - any water acct that is over \$1,000 has been put on the property owners taxes. Any other balances over 3 months past due will receive letters regarding payment or shut off will take place. B) BOARD CONCERNS: AD FOR AUDITOR – Telephone Time will run an ad for \$99 .Clerk Casiano made motion to run the ad and supported by Treasurer Haag.

NEW BUSINESS: A) CEMETERY ORDINANCE – tabled till next month B) Street Signs – Discussion was had regarding the recent vandalism of street signs. Supervisor Hoenig addressed the Board stating that if anyone has a problem they should contact a Board member or come to a Board meeting so the concerns could be resolved instead of taking matter into your own hands. C) Proposal 2 – Clerk Casiano stated that with elections next year and the new proposal 2 that was voted onthe City of Crystal Falls will be taking over the early elections for our district. Election Day will still be at the regular location. D) Christian from Wickwire addressed the Board regarding Tire grant. This will allow the disposal of up to 3k which is approx. 400 tires for residential disposal. The rims must be removed. Supervisor Hoenig made the motion to approve and supported by Treasurer Haag.
